Sidney Barrow Galloway was born June 29, 1929, and lived in Shreveport all of his life except for time spent in school at LSU in Baton Rouge and while serving his country in the United States Air Force. He received his B.A. degree from LSU and his L.L.B./J.D. from the LSU Law School, graduating in 1955.

Sid was a member of Sigma ~~Kappa~~ ^{Alpha Kappa} Epsilon fraternity and a member of Phi Kappa Phi legal fraternity and Gamma Eta Gamma. He was awarded membership in the Order of the Coif and was Associate Editor of the Law Review.

He returned home to join the firm of Cook, Clark, Egan, Yancey & King, later renamed Cook, Yancey, King & Galloway, from 1955 until his untimely death on September 20, 2000 while vacationing in Victoria, British Columbia, with his beloved wife, Jean. He practiced law over forty-five years.

He was a devoted member of St. Paul's Episcopal Church, serving as Senior Warden of the Vestry, as a Stephen Minister trainer, Co-Chair of the Registration Committee of the Con-

vention 2000, a member of the Brotherhood of St. Andrew, a lay Curate and of the Lay Eucharistic team. He was serving as Parish Administrator and as Chancellor of St. Paul's Parish. He was on the steering committee of the Shreveport/Bossier Mayors' Prayer Breakfast and had served as its chairman.

As expressed at his funeral, Sidney did not just profess his Christianity, he lived it.

As a lawyer, he enjoyed the highest compliment that can be bestowed one in that profession, being a Lawyer's lawyer. His clients included the one giving this address. Sid was a member of the Shreveport, Louisiana State and American Bar Associations and served as President of the Shreveport Bar Association in 1994. He was also a member of the Tax and Estate Planning Council, serving as president and Board Member. He was chosen Boss of the Year in 1992 by the Shreveport Legal Secretaries Association.

Sidney was preceded in death by his father, Judge James U. Galloway, and his mother, Sydney Barrow Galloway, and by his brothers, James Ulon Galloway, Jr. and Dr. Edgar Galloway.

He is survived by his wife of 47 years, Jean Sink Galloway; his children Carolyn Galloway Melsheimer, Sidney Barrow Galloway, Jr. and his wife, Linda, and Charlotte Galloway Lewis and her husband, Brian, nine grandchildren, Erin and Sydney Melsheimer, Steven, Kathleen, Amy, Michael, Lisa and David Galloway, and Mary Charlotte Lewis, special family


friend, Jerline Henson and numerous nieces and nephews.

Sid was a quiet man, highly intelligent and with a great sense of humor. He was moved by a strong desire to serve his God and his fellow man and he fulfilled this every day of his life. Totally unselfish, he was never too busy to help the many who called on him for advice and counsel. Many a young lawyer benefitted from his willingness to share time with them as he smoothed their journey over the rough spots encountered in the practice of law. His clients were devoted to him and looked on him as far more than their lawyer but also as their friend.

In summary, Sidney Galloway was the complete man. Devoted to his God, his family, his country, his friends and his community he did not lose his life, rather he willingly gave it in service to others. He was the true good and faithful servant.

And now to his wife, Jean, his children Carolyn, Sidney and Charlotte, his grandchildren, and to his host of friends and to this Court, this Memorial to Sidney Barrow Galloway is submitted with the request it be inscribed in the Records of the First Judicial District Court and copies be provided his family.
