The LEP individual will need to come to the Court in person and be directed by Sheriff's security staff to the second floor to contact the Court's receptionist. The Language Access Coordinator will be contacted immediately and if the Spanish interpreter is not on the Court's premises, she will be contacted immediately to speak with the LEP individual. Should another language be needed then the coordinator will call Language Line Solutions.

The information sheet will be translated by Valentina Poggioli who has been certified by the Louisiana Supreme Court as a certified Spanish Interpreter. Any other language needed, Language Line will be contacted.

The Caddo Parish Juvenile Court will provide language interpretation services in court or out of court for Delinquency, Family In Need of Services (FINS), Temporary Restraining Orders (TRO), Child In Need of Care (CINC), Traffic Court, Child Support, Truancy, and Probation Officers' reviews and counseling with adjudicated youth, and their parents or guardian.

L. Language Access Complaint Process

This court has taken the following steps to publicize Louisiana's centralized language access compliant process:

- 1. The complaint process is posted on the Caddo Parish Commission's website; and
- 2. Our receptionists are trained to assist individuals to fill out a written complaint form (with the assistance of an interpreter) if the is present at court.
- 3. Should the LEP individual decide that the complaint was not adequately addressed then the interpreter will access the Louisiana Supreme Court Language Access website and assist filing the complaint form.

Louisiana Language Access Plan Implementation Order

ORDER

Caddo Parish Juvenile Court Caddo Parish, State of Louisiana

WHEREAS, the Louisiana Supreme Court signed a Memorandum of Agreement with the United States Department of Justice mandating that all courts phase-in a language access program that provides language assistance services at no cost to Limited English Proficient (LEP) individuals in all state court proceedings and operations;

WHEREAS, the Louisiana Supreme Court adopted a statewide Language Access Plan that, among other things, required the adoption of a language access plan in each court;

WHEREAS, federal law requires that courts provide language assistance services to LEP individuals, including court interpreters, at no cost to the individual;

IT IS HEREBY ORDERED that the Caddo Parish Juvenile Court (hereinafter "the Court") appoints a Language Access Coordinator who is responsible for coordinating language assistance services in the Court;

IT IS FURTHER ORDERED that the Court shall submit the name of its appointed Language Access Coordinator and all relevant contact information to the Supreme Court's Office of Language Access;

IT IS FURTHER ORDERED that the Court shall advise the Supreme Court's Office of Language Access if a new Language Access Coordinator is appointed;

IT IS FURTHER ORDERED that the Court's Language Access Coordinator will cooperate with the Supreme Court's Office of Language Access to implement the statewide language access planand will remain responsive to individual requests for language assistance services;

IT IS FURTHER ORDERED that the Court adopts the attached Language Access Plan for the Court and shall periodically review and adopt new language assistance services policies and procedures as required by law.
