CET, Jr. was born in July 19, 1912, in DeRidder, La. His family lived in Arcadia and Ruston.he had just turned 74 in July.

He was an eagle scout. He graduated from Louisiana Tech, and then graduated from Tulane

College of Law June 12, 1935.

He was admitted to practice law in Louisiana on July 12, 1935. He was a Lieut. Commander in the United States Navy during WWII, stationed in the Pacific at the time of the Battle of Midway.. He was an attorney for over 51 years, and on April 26, 1985 was recognized by the Louisiana Bar Assn. for 50 years membership. He served two terms in the Louisiana Senate, taking the oath of office on May 10, 1948 and May 17, 1952.

Admitted to practice before the Interstate Commerce Commission July 2, 1953.
