RESOLUTION OF THE SHREVEPORT BAR ASSOCIATION
PRESENTED OCTOBER 28, 1985
IN MEMORY OF MALCOLM WEILLER FEIST
TO THE FIRST JUDICIAL DISTRICT COURT
CADDO PARISH, LOUISIANA



"On February 19, 1985, the God of time and eternity called Malcolm Weiller Feist to his eternal rest.

Malcolm was born in Shreveport, Louisiana, on November 18, 1905, the son of Samuel Feist and Eunice Weiller Feist. Both of his parents were natives of Louisiana. His father was born in Millikens Bend and his mother in Shreveport.

Prior to college, Malcolm was educated in various schools in Shreveport. He attended and received an A.B. degree from Washington University in St. Louis, Missouri. While attending Washington University, he was admitted to Phi Beta Kappa National Honor Society. Subsequent to his graduation from college, he enrolled in the Law School of Tulane University, from which he graduated in 1926 with an L.L.B. degree.

Shortly after receiving his law degree, Malcolm opened his office in Shreveport. He pursued his chosen profession from the time he was admitted to the Bar until his death, except for a period during World War II when he served in the Army Air Forces. (Having entered as a private, he attended Army Air Forces Officers Candidate School and had attained the rank of captain when he received his certificate of service.)

Malcolm was a student of the law. His personal annotated Civil Code and Code of Practice provided a handy tool to the location of solutions to many legal problems. His knowledge of the law was the envy of members of the Shreveport Bar, and he was kind and considerate in helping other attorneys.

In 1940 and 1948, he served the Shreveport Bar Association as its Vice President, and in 1978, he was elected President of the Association. He was a tireless worker for various Bar Associations and served in many different capacities for the benefit of the Bar Association and the public.

During the almost sixty years he practiced, he was associated with many of the leading members of the Shreveport Bar Association. At the time of his death, he was a member of the firm of Evans, Feist, Auer & Keene.

In writing his will, he demonstrated his concern for his community and his fellow man by leaving very substantial properties to the LSU Board of Supervisors for the use and benefit of the LSU Medical Center in Shreveport.

Malcolm loved sports, particularly tennis. He was an excellent player. From the time he was a teenager until the year in which he died at the age of 79, rarely a week ever passed that he could not be found at Princess Park, in the old days, or at Querbes Tennis Center or Pierremont Oaks Tennis Club, in recent years, playing tennis or socializing with his tennis pals.

Malcolm will be missed by those with whom he was associated and his clients who held him in the highest esteem.

Malcolm is survived by his brother, Carroll W. Feist.
