After that, he continued and enjoyed his private practice with his son, Michael, who had recently graduated from law school. One of his many pleasures in his private practice was arguing two cases in before the United States Supreme Court.

Will was an avid handball player playing most days at lunch at the YMCA in downtown Shreveport. He played in many regional tournaments. He was nationally rated.

Once retired, Will and his wife, Dorothy "Dot" Akin Cady, enjoyed many years at their camp on Big Lake, south of Lake Charles. He loved having a house near the water. His greatest joy was pulling in a huge redfish and cooking it on the grill for dinner that evening.
