We, the Members of the Shreveport Bar Association, deploring the loss of one of our older and honorable members and with heartfelt sympathy for his widow and family, offer this resolution to his memory.

Emile Thomas Geneux was born in Ashdown, Arkansas, the son of Arthur L. Geneux and Frances Gunther Geneux. He and his family moved to Shreveport when he was very young. He attended public schools in Shreveport, and graduated from St. John's High School, now Loyola College Prep. He studied law at Centenary College of Louisiana, took the bar examination, and was admitted to practice law in July, 1943. He was a graduate of Louisiana State University School of Banking of the South in 1954.

Following graduation from high school, he was employed by the Commercial National Bank in 1927. He remained in the employment of the bank until 1974, when he retired after 47 years of faithful and loyal service. He served the bank in numerous capacities during his tenure of employment and was Vice President and Manager of the Operations Center at the time of his retirement.

Although he never entered the active practice of law, he was keenly interested in various phases of the law, particularly that of banking, negotiable instruments and those pertaining to employer/employee relations. He was a member of the Shreveport Bar Association and the Louisiana State Bar Association.

He was a veteran of World War II, having served in the Navy from August, 1943, until his honorable discharge in February, 1946, as a Petty Officer. He was a member of the American Legion. Emile was a member of St. Elizabeth Seton Catholic church.

Emile Geneux's love for his home life and his devotion to his wife and family were among the most notable traits of his character. He is survived by his beloved and devoted wife, Ruth Babin Geneux; his son, T. Lynn Geneux; and two grandchildren. We extend our deepest sympathy to them.

BE IT RESOLVED THEREFORE that this memorial be presented and read at memorial exercises to be held in the First Judicial District Court, Caddo Parish, Louisiana, under the auspices of the Shreveport Bar Association on October 28, 1985, and that it be presented to the Supreme Court of Louisiana at memorial exercises to be held under the auspices of the Louisiana State Bar Association.

BE IT FURTHER RESOLVED that copies of this memorial be delivered to the members of the immediate family of Emile Thomas Geneux, and spread upon the minute records of the First Judicial District Court.
