MEMORIAL TO

FERNEY ADAMS MOORE, JR.

May 2, 1923 - February 17, 1982

Presented to the First
Judicial District Court
of Louisiana in and for
Caddo Parish by the under-
signed Committee designated
by the President of the
Shreveport Bar Association
to prepare and submit a
resolution in memory of the
late Ferney Adams Moore, Jr.
a member of the Bar of this
Court and of this Association.

Ferney Adams Moore, Jr., who was better known as F.A., is survived by his widow, Jeanne Stamper Moore, two sons, Ferney Adams Moore, III, a doctor residing in Baton Rouge, Louisiana, and George Stamper Moore, an attorney practicing in New Orleans, Louisiana, and his mother, Mrs. Ferney Adams Moore, who resides in Shreveport.

F.A. Moore was born in DeRidder, Louisiana and moved with his family to Shreveport, Louisiana at an early age and attended the Shreveport schools, graduating from Byrd High School in 1940. During these years, he developed a love for music which continued during his lifetime. He entered Louisiana State University in the College of Commerce. He was a member of Phi Delta Theta fraternity.

F.A.'s academic studies were interrupted by his entry into the Army during World War II, where he served in Ordnance and attained the rank of Captain. He later qualified and continued in the reserve as a Judge Advocate.

F.A. returned to Louisiana State University to continue in the College of Commerce and was graduated with a degree in Business Administration in 1947. He entered law school at L.S.U. and received his law degree in 1950. He was admitted to practice before the Supreme Court of the State

of Louisiana and the Courts of Louisiana in 1950. He has continued as a member of the Bar of the State of Louisiana since that date.

Except for a period of time when he was in private practice with Joseph Bethard, F.A. used his legal background, experience and education in his employment, as a partner, and as an officer in Querbes & Nelson, Inc., formerly known as Querbes & Bourquin. During the first ten years of his association with Querbes & Nelson, he was the claims manager. This was the period during which maritime law as applicable to the petroleum industry was in its infancy and development. At that time the claims department was the regional claims office for a number of major insurance companies. F.A. in his later years with Querbes & Nelson specialized in casualty insurance service and production, particularly in oil and gas-related industries. He continued to contribute the benefits of his legal knowledge in dealing with matters which arose involving the clients of Querbes & Nelson with whom he had a very close association. Many of his fellow attorneys in private practice would often call F.A. to obtain the benefits of his specialized knowledge.

NOW, THEREFORE, BE IT RESOLVED that we, the members of the Shreveport Bar Association, hereby affirm the respect, the admiration and the regard in which we held Ferney Adams Moore, Jr. for his character, ability, industry, skill and learning and for his example of the fine person that he was and we extend to his wife, sons, mother, and other members of his family and friends our sincere sympathy.

BE IT FURTHER RESOLVED that this memorial and resolution be made a part of the records of this Court and that copies

of the record hereof be delivered to the members of the
family of Ferney Adams Moore, Jr.
