

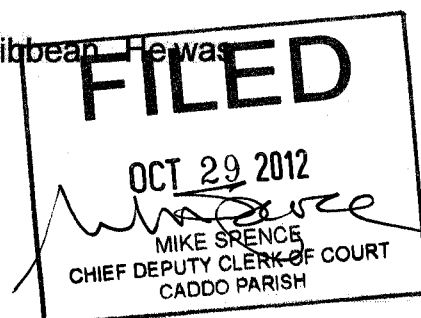
MEMORIAL FOR

Hubert J. (Hugh) Hansen was born in Lake Charles, Louisiana on July 21, 1926, and passed away on April 27, 2012. Mr. Hansen served in the Army Air Corps as an Aviation Cadet. He attended John McNeese Junior College, LSU and graduated from LSU Law School in 1949. He became a CPA in 1954.

In 1954, Mr. Hansen joined Pioneer Bank and Trust Company. He served in every official capacity including Vice-President, President, Chairman of the Board, Senior Chairman and retired after 40 years when the bank was acquired by Hibernia National Bank.

Hugh served on the boards of numerous local and state organizations. He served on the Legislative Committee of the Louisiana Bankers Association for over 35 years, served two 3-year terms on the Government Relations Committee of the American Bankers Association, and taught at SMU Banking School for ten years. Hugh also was President of the Louisiana Bankers Association in 1994-1995. Hugh served as Treasurer and member of the Executive Committee of the Shreveport Chamber of Commerce and Chairman of the Shreveport Development Board. He was a member of the Shreveport Rotary Club, Shreveport County Club, Cambridge Club, Shreveport Yacht Club, and the Cypremort Yacht Club. He was active in the Washington Mardi Gras from 1968-1983. He was a charter Member of the Krewe of Justinian and served as King Justinian IV.

Hugh was an avid golfer, duck, dove and quail hunter. He developed a love for sailing and spent many hours on Cross Lake and sailing the Caribbean. He was




a world traveler and he and Pat shared many wonderful trips together. Hugh was an excellent business partner, golfing buddy to numerous friends, a wonderful neighbor and, under the guidance of Pat, a very good cook.

Hugh is survived by his wife Patricia Cyr Hansen, daughters, Gayle Hansen Browne, Kathryn Hansen Moss, Patricia Hansen Waddle, Marilyn Hansen Timbs and Amy Hansen Henry, son Michael Patrick Norris, eight grandchildren and three great grandchildren.
