Joseph Francis Giglio, III, was born in Shreveport on June 7, 1930, the only child of Joseph F. Giglio, Jr. and Sarah Cush Giglio. He attended public grammar school and high school in Shreveport after which he attended Springhill College, Mobile, Alabama, from which he graduated with a Bachelor of Science degree. He subsequently attended Loyola Law School in New Orleans from which he graduated with a Bachelor of Law degree in 1953.

Joe was a member of the Armed Forces and served in Europe during his tour of military duty. After his honorable discharge from the Army he then established his law practice in Shreveport where it remained until his untimely death on May 12, 1983 at age 52.

During his years of practice Joe was associated with Charles Emery, Maynard Cush and then Algie Brown with whom he remained associated for a number of years and up until the time of his death.

Throughout his years of practice Joe exhibited those traits which best exemplify our profession; a concern for people and a desire to help them, a dedication to the law and a thoroughness in his work to achieve a job well done. His reputation as an expert, particularly in the field of real estate law, was well known among his colleagues. He was truly a credit to his profession.

Devoted as he was to his profession, Joe still found time to engage in a number of fraternal, religious and civic affairs. He was a member of the Knights of Columbus, Broadmoor Council, the 4th degree Knights and held membership in Shreveport Lodge 122 of the Elks. For years he was an active member of St. Joseph's Church where he taught classes in religion to high school students.

For more than twenty five years he was active in the Civitan Club, having held the offices of President of the Shreveport Chapter, Judge Advocate of the Northwest Louisiana District and Governor of this district in 1965-1966.

He was a member of C-BARC and served on its board of directors for several years.

His most dedicated civic activity centered on helping the youth of our community. Joe was totally dedicated to the scouting program

for a number of years and worked diligently in it always showing a love for children and a desire to enrich their lives. His scouting activities, that virtually spanned a lifetime, included membership in the Boy Scouts of America, assistant cub master in Pack 32 at Riverside School, committee chairman of Troop 4, explorer advisor of Post 94, District advancement chairman, member of the Catholic committee on scouting, member of the camp property committee of the Pelican Council of Girl Scouts and many others.






