

BYRON DUTY BULLOCK

Byron Duty Bullock was born in Ingram, Texas, on November 3, 1899, the son of Otis W. Bullock and Mrs. Jessie L. Duty Bullock.

While he was still a boy, he moved to Shreveport with his family and there attended school.

After graduating from the Shreveport High School in 1918, he entered Harvard College, from which institution he received his A. B. degree in 1922. Subsequent to his graduation from Harvard College, he entered Harvard Law School and graduated therefrom in 1927 with an L.L.B. degree.

While he was a student at Harvard, he met Miss Minnie Munroe of Boston, Massachusetts, and later, in 1934, they were married.

In 1928 he was admitted to practice in Louisiana and became associated in practice with his father and the other members of the firm of Barksdale, Bullock, Warren, Clark & Van Hook. This firm, after the death of Howard B. Warren, was succeeded by the firm of Barksdale, Bullock, Clark & Van Hook, which, in turn, was dissolved in 1942. Thereafter, Byron Duty Bullock practiced law with his father, Otis W. Bullock, and his brother, Alfred W. Bullock, until his untimely death on April 11, 1953.

During World War II, Byron Duty Bullock served his country well as Assistant Wage Stabilization Director, Eighth Regional War Labor Board, and as Assistant Chief Attorney, Special Service Branch, War Stabilization Board.


Byron Duty Bullock was a member of the Harvard Law School Association, Harvard Club of Louisiana, Shreveport Bar Association, Louisiana Bar Association and the American Bar Association; he was a lawyer whose professional ethics were of the highest, whose scholarly attainments and thoroughness in his work were recognized by his fellow members of the bar and whose modest bearing and lofty ideals endeared him to his associates and friends.




