**IN MEMORIAM**

**SIDNEY GLENN MYERS**

**March 21, 1894 - September 2, 1955**

The death of Sidney Glenn Myers, at his home in Shreveport, Louisiana, on September 8, 1955, marked the passing of a very courageous member of the Shreveport Bar.

Approximately four months before his death Mr. Myers underwent surgery and although he and his many friends entertained high hopes of his recovery, it was ordained otherwise.

Mr. Myers was born on March 31, 1894, in Woodville, Wilkinson County, Mississippi, the son of Edward W. and May Lewis Myers. His parents moved to the City of Vicksburg, Mississippi, where Mr. Myers attended school and in which community he was reared. His parents moved to Shreveport after he had finished his education. In 1917, upon the outbreak of World War I, he went to Ft. Logan H. Root training camp where he was commissioned as a lieutenant of infantry. Thereafter, he served in the American expeditionary forces in Europe until some months after the termination of the war. Upon his discharge, Mr. Myers worked in law offices, studying the law during his spare moments. He passed the Bar examination with the highest score in his group in 1924 and was at once admitted to practice.

Mr. Myers specialized in oil, gas and mineral law. In 1951 he organized the firm of Myers, Gatti & Egan, composed of himself, John S. Gatti and Reuben W. Egan, all of Shreveport, Louisiana, of which firm he was the senior partner at the time of his death.

Mr. Myers was of a quiet, retiring disposition and made friends very readily, of whom he was exceedingly fond and loyal. He was a man of tremendous fortitude and courage. He tackled and overcame many obstacles during his life.

He was a member of St. Mark's Episcopal Church, of the Shreveport and Louisiana Bar Associations and of the American Bar Association. He was also a member of the American Legion and La Societe des 40 Hommes et 8 Chevaux, in which organizations he took an active part.

Mr. Myers was married in 1923 to Nellie Martha Green, daughter of D. W. Green, of Camden, Arkansas, with whom he resided up to the date of his death. He is survived by his widow; a son, Sidney Glenn Myers, Jr., and a daughter, Mrs. Norman C. Cox; three sisters, Mrs. W. F. Buckelew, Mrs. C. R. Minor, Jr., and Mrs. W. H. Wert; a brother, E. W. Myers; three grandchildren and four nieces and nine nephews.

The passing of Mr. Myers was a blow, not only to the members of his family and to the members of his firm, but a loss to all of his friends and the members of the Shreveport and Louisiana Bar.
